Plat Submission Requirements

Submission of the preliminary and final plats can be found under Subdivision Regulations Sections [14-1-31](#) through [14-1-33](#). Technical requirements for preliminary and final plats can be found under Subdivision Regulations [Section 14-1-40](#) and [Section 14-1-41](#). Although the ordinance states the City needs twenty (20) copies of the plats, please verify the number of copies with Planning Staff prior to printing as technology has significantly reduced the number of copies and this may fluctuate based on staffing numbers. The applicant is required to submit an electronic copy that has a measurable scale.

Mailing Requirements For Plats/ Referral to Other Agencies & Utilities. (per Section 14-1-31)

Plats must be reviewed by several governmental agencies. The applicant must forward copies of the preliminary plat to these agencies prior to action by the Plan Commission. The applicant must provide the City with confirmation of proof which verifies that the required agencies received copies of the plat.
